#### Applicant eligibility

- \* Minimum age 18 (minimum age 16 with parental consent) and female gender by birth
- \* Never married and not given birth to a child
- \* Minimum 159 cm
- \* Minimum High school diploma
- \* Hold NO previous or current criminal record
- \* Not an employee or family member of Miss Asia Canada Organization and/or its subsidiaries
- \* Not bound by an legal contracts prohibiting the participation in Miss Asia Canada pageant
- \* Holds a valid passport for entry into other countries
- \* All previous, current and future social media posts are aligned with Miss Asia Canada's beliefs
- \* Abide by vaccine requirements for travel
- \* Nominated by a Recruitment Agent or Nominator or by a qualified Guarantor/Guardian

#### **Eligibility of Nominator/Guardian**

- \* Holds a valid passport recognized by participating countries
- \* Not an employee of family member of Miss Asia Canada Organization and/or its
- subsidiaries
- \* Able to nominate a maximum of 2 applicants
- \* Nominator may include parents, family members, and business associates

#### **Documentation required**

\* All applicants are required to produce the following upon selection

- i) Original copy of Passport and all travel documents required by participating countries for travel
- ii) Original copies of education certificates
- iii) Two(2) photos, 1 head shot and 1 full length body shot
- iv) A copy of Nominator and/or Guardian passport recognized by the participating countries (if applicable)

#### **Registration fees & Sponsorship rules**

- \* i) Once selected, a registration fee of \$ 1000.00 is to be submitted with the completed application (Optional payment of \$500x2)
- \* ii) In addition, delegates are required to secure at least 1 sponsor for \$ 500.00 (information provided in the Contestant
- Handbook)
- \* **OR** pledge 10 general admission or 5 VIP seats for the National pageant
- \* All payments including from sponsors to be made by etransfer to: payment@gemgroup.ca

### Selection Process

- \* Miss Asia Canada organization reserves the right to select applicants that are suitable representatives of a Title Holder
- \* Once selected entry fees due within 5 business days (Payment options available)
- \* Miss Asia Canada Organization will create a group chat for group discussions
- \* The Miss Asia Canada Contestant Handbook will be provided electronically once fees have been received
- \* Delegates are required to participate in all activities, training sessions, photo sessions required by Miss Asia Canada Org.
- \* Withdrawal from the pageant must be approved by the Director and each case will be considered on an individual basis.
- \* All fees are non-refundable
- \* Miss Asia Canada deems all rights to select candidates up to one week prior to Nationals at its discretion

#### **Privacy Protection & Information Use**

- \* All information, documentation and photos provided are non-returnable once submitted
- \* Information on applicants not selected will be put into Miss Asia Canada database
- \* All photos, videos, social media content becomes the ownership of Miss Asia Canada used for the purpose of marketing
- \* All applicants hereby consent to permit Miss Asia Canada to use their personal information, including photos and videos
- i) For promoting the Miss Asia Canada Pageant and for social media posts before, during and after the pageant
- ii) For any promotional, marketing, sponsorship and other activities related to the pageant
- iii) For any third party promotional marketing, advertising and modelling opportunities

#### Other

Miss Asia Canada Organization reserves the right to:

- i) Waive or relax any criterion or rules and regulation it sees fit when and if necessary under specific circumstances
   ii) Disqualify any contestant at any time during the pageant process for any reasons deemed harmful to the reputation of Miss Asia
- Canada Organization, its participants and employees, including breach of contract, saying misleading information and defamation
- iii) Select and replace a suitable finalist if she withdraws from the competition prior to the pageant
